RESALE ENFORCEMENT AGREEMENT

I understand that it is strictly forbidden to resell any certified or non certified items at the Felton Certified Farmers Market. I am also aware of the state law that forbids the resale of produce at a State Certified Farmers Market. I realize that reselling such items will result in the following;

PENALTY FOR PRODUCERS WHO RESELL PRODUCTS

Upon first violation, FCFM may suspend and/or fine, subject to the discretion of the FCFM Board of Directors, the owner(s), grower(s), employee(s) or other representatives associated with the business and withdraw all seniority for same. Suspended party(s) shall not sell for her/himself or on behalf of any other producer for a minimum of one year at FCFM. Upon second violation, the suspended party will be permanently disqualified.

Upon violation, FCFM may notify the Department of Food and Agriculture, the Direct Marketing industry and other industries associated with the product.

PROCESS FOR VIOLATIONS OF STATE, COUNTY OR MARKET RULES

FCFM will give verbal and written notice of violations. Violations resulting from employee actions are the full responsibility of the employer. Second notices will result in suspension.

Also: The undersigned producer agrees to indemnify and save harmless Felton Certified Farmers Market, its Board of Directors, agents, servants and employees from any governmental fines, penalties, assessments etc. and any damage, injury or loss to any person or persons, including, but not limited to, persons to whom the grower/vendor may be liable under any Workers Compensation law and the producer him/herself, and from any loss, damages, cause of action, claims or suits for damages, including, but not limited to, loss of property, goods or merchandise, caused by, arising out of, or in any way connected with producers use of the privileges herein granted.

FCFM shall not be liable for losses or any other liabilities whatsoever, for the failure to operate a market due to holidays, destruction by fire or other calamity, or by act of God, strikes, statutes, ordinances, or any legal authority or any other cause beyond Felton Certified Farmers Market's control.
